



# **Return and Refund Policy**

Thank you for shopping at AJs Products website and AJs Products app.

If, for any reason, You are not completely satisfied with a purchase We invite You to review our policy on refunds and returns.

The following terms are applicable for any products that You purchased with Us.

## **Interpretation and Definitions**

### **Interpretation**

The words of which the initial letter is capitalized have meanings defined under the following conditions. The following definitions shall have the same meaning regardless of whether they appear in singular or in plural.

### **Definitions**

For the purposes of this Return and Refund Policy:

- **Application** means the software program provided by the Company downloaded by You on any electronic device, named AJs Products
- **Company** (referred to as either "the Company", "We", "Us" or "Our" in this Agreement) refers to AJs Products, LLC., PO Box 495.
- **Goods** refer to the items offered for sale on the Service.
- **Orders** mean a request by You to purchase Goods from Us.
- **Service** refers to the Application or the Website or both.
- **Website** refers to AJs Products, accessible from [www.ajsproducts.us](http://www.ajsproducts.us)
- **You** means the individual accessing or using the Service, or the company, or other legal entity on behalf of which such individual is accessing or using the Service, as applicable.

## **Your Order Cancellation Rights**

You are entitled to cancel Your Order within 14 days without giving any reason for doing so.

The deadline for cancelling an Order is 14 days from the date on which You received the Goods or on which a third party you have appointed, who is not the carrier, takes possession of the product delivered.

In order to exercise Your right of cancellation, You must inform Us of your decision by means of a clear statement.

We will reimburse You no later than 14 days from the day on which We receive the returned Goods. We will use the same means of payment as You used for the Order, and You will not incur any fees for such reimbursement.

## **Conditions for Returns**

In order for the Goods to be eligible for a return, please make sure that:

- The Goods were purchased in the last 14 days
- The Goods are in the original packaging
- The Goods were not used or damaged
- You have the receipt or proof of purchase

The following Goods cannot be returned:

- The supply of Goods made to Your specifications or clearly personalized.
- The supply of Goods which according to their nature are not suitable to be returned, deteriorate rapidly or where the date of expiry is over.
- The supply of Goods which are not suitable for return due to health protection or hygiene reasons and were unsealed after delivery.
- The supply of Goods which are, after delivery, according to their nature, inseparably mixed with other items.

We reserve the right to refuse returns of any merchandise that does not meet the above return conditions in our sole discretion.

## **Returning Goods**

You are responsible for the cost and risk of returning the Goods to Us.

## **Recall Event**

Parts are produced in batches and the traceability to that batch can be found in the Bar Code Serial #. If a Recall Event were to occur, the Serial # Range will be communicated to the buyers within that range.

In the event of a recall, please be able to supply the following information:

- The original packaging Barcode Information
- The physical packaging

If the original packaging cannot be provided, any warranty claim will be rejected.

## **Exchanges**

If you need to exchange a product for the same one, contact us. Please note that We only replace Goods you received defective or damaged.

## **Gifts**

If the Goods were marked as a gift when purchased and then shipped directly to you, You'll receive a gift credit for the value of your return. Once the returned product is received, a gift certificate will be mailed to You.

If the Goods weren't marked as a gift when purchased, or the gift giver had the Order shipped to themselves to give it to You later, We will send the refund to the gift giver.
